Part 2 – Articles of Agreement (Region Certificate of Incorporation)

<u>Purpose</u> – The purpose of this Part is to provide the user with a readily available copy of the current Region "Articles of Incorporation" which define the statutory powers of the incorporated Region

By vote of the Region's Board of Directors, the Northeast Region is incorporated in the state of New Hampshire as a "Nonprofit" Corporation pursuant to Chapter 292 of the New Hampshire Statutes Annotated. This incorporation provides individual liability protection for volunteers serving in a Region capacity or serving on behalf or the Region as well as other benefits.

The powers granted by the state of New Hampshire are the primary governing authority of the Region. To maintain the benefits of the corporate status, the Region must work within the limits imposed by the state statute.
